From Route 80 East or West

Exit at #25 to Route 206 North – travel thru 4 traffic lights, At 4th light (Cranberry Deli on your right) stay straight, turn left at the 3rd side street, you will be turning just prior to the Shell Gas Station – go under small RR trestle and make the IMMEDIATE right turn into the school's driveway.

From Route 287

Exit for Route 206 North, Netcong, - Travel thru Chester, Flanders, get onto Route 80 West to Exit #25. Follow directions above

AWARDS

A qualifying ribbon will be awarded to each team who earns a score of 170 or higher.

First Place.....Blue Rosette
Second Place.....Red Rosette
Third Place.....Yellow Rosette
Fourth Place.....White Rosette

Placement rosettes will be given to the four top scoring teams in each class.

New title rosettes will be given to any team earning a new title.

A rosette will be awarded for High in Trial.

Notice to Exhibitors

Competitors, through submission of entry, acknowledge that they are knowledgeable of CDSP Competition Obedience rules and regulations including but not limited to the following rules regarding entry:

- ◆ This trial is open to all dogs being at least six months of age, including purebred and non-purebred, except bitches in season or dogs with disabilities, injuries or illnesses which may cause the dog pain or great discomfort, or dogs exhibiting signs of aggression that threaten the safety of other dogs or humans.
- ◆ All dogs must be registered with CDSP obedience to compete.
- ◆ Dogs must be shown by a member of the owner's immediate family: mother, father, spouse, life partner, sibling, child, grandparent, or grandchild.
- ◆ Safety shall always be of foremost consideration in actions and conduct by handlers at all times. Handlers, through entry at this event, accept full responsibility for themselves and the actions of their dogs.
- ◆ The organizing committee may refuse any entry for any reason.

In addition,

- ◆ THERE SHALL BE NO REFUND for entries withdrawn or in the event a dog and/or handler are dismissed from competition, regardless of reason for such dismissal. There will be no refunds if the trial has to be cancelled for any reason.
 - ◆ Returned checks do not constitute a valid entry. There will be a \$25.00 service charge for returned checks. Payment of entry fees and service charges shall be made in cash or money order within 30 days of postmark of notice of returned check here notification is received after event date. Any fees not received within 30 days of notice result in cancellation of event results for all classes for the registration number(s) of delinquent entry/entries. No reinstatement of results is possible, and all awards must be returned within 10 days of notification, or the dog's registration may be suspended pending restitution. Any unpaid fees or shortfalls must be paid prior to the start of the event or entry is canceled without recourse by owner/handler.
 - ◆ No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, Act of God, public emergency, act of a public enemy, strike or any other cause beyond the control of the organizers.
 - ◆ All dogs shall be shown in a flat buckle or snap collar, or properly fitted martingale (limited slip) collar. No choke collar, prong collars, shock collars, harnesses, martingale leads, or head collars are allowed.
 - ◆ All competitors through entry at this event waive any and all rights relative to video broadcast of this event. Competitors shall have the right to videotape portions of this event for their personal use only. No portion of this event may be videotaped for commercial or other purposes. Owners with disabilities are encouraged to compete. Any necessary modifications to the exercises must be provided by the handler to the judge and approved by the judge.
 - ◆ Exhibitors that plan to use food as a reward in the ring must indicate that on their entry forms. All teams NOT using food shall be scheduled to compete before those teams using food.
 - ◆ Dogs must be on leash while on show grounds
 - ◆ Please pick up after your dog and yourself

- This is an indoor trial. Rings and class times will be determined after entries are received and will be sent with confirmations.
- Starting time for trial 2 will be sent at that time also.
- Food and refreshments will not be served; please plan accordingly. There are plenty of places to go pick up some lunch close to the school.
- Parking is very limited, parking is in the school lot only – no street parking allowed.
- This is a one ring trial with limited crate space. Please try to make arrangements to leave your un-entered dogs at home.
- There will be no refunds for absent entries. Refunds will be made for withdrawn entries only if request is made prior to closing date and can be filled by the waiting list. Refunds will be made for bitches in season if request is accompanied by a note from the exhibitor's veterinarian.

GENERAL AGREEMENT
